I understand that I assume all responsibility for my pet's behavior/conduct/actions during this event. **I assume all risks, injuries, damages sustained by my dog or myself - regardless of fault or negligence.**

NSF Inc, officers, planning committee and official event volunteers reserve the right for any reason they see fit to deny any person, dog, entrance and ejection from this event. NSF is fully released from liability, responsibility, claims, demands or causes of action arising from any injuries or damages incurred to humans, dogs, negligence and altercations. I grant NSF perpetual right to use for publicity, promotional purposes my name, dog pictures in any media without any liability or obligation to me.

\*Participants are expected to practice responsible pet ownership.

\*Dogs must be well-behaved, unaggressive and comfortable in crowded, stimulating, noisy environments where other dogs and children present.

\*All dogs must wear identification (collar tags, microchip) on a fixed lead or retractable leash of no longer than 6 feet.

\*Dogs must be within 3 feet of the owner, guardian or attendant at all times.

\*Dogs must be healthy, free from parasites with flea control regiment. Mandatory vaccines are current (DHLF-distemper, Hepatitis, Leptospirosis, Parvovirus) Parvo, Bordetella and Rabies.

\*All dogs must be altered, spayed.

\*Dog participants are expected to utilize designated comfort station; owners are solely responsible for clean-up of their pets.

\*Food and other treat samples may be passed out. Owners must be aware of how their pet responds to food atypical from their diet.
